## The Power of Love and Unity: The Garcia Family's Story

Love is what binds us to all whom we care about and unity is what gives us the strength to overcome life's greatest challenges. This was very evident in the case of Frank Joseph Garcia, who after contracting COVID-19, went from a strong and fit 65-year-old, to a man fighting for his life. And for his daughter, Marcy, who just two months after Frank recovered, was admitted to Royal Inland Hospital in premature labour, giving birth to her son just hours later.

Frank Garcia was diagnosed with COVID-19 in March, 2020. He was intubated and sent by ambulance from Merritt to the Royal Inland Hospital. Following his admittance, he spent 67 days in the ICU with 42 of them in a coma. When Frank regained consciousness, the recovery process required hard work and dedication from Frank himself and the team of medical staff working alongside him but **TOGETHER** they made it possible.

In the months following Frank's discharge, his pregnant daughter Marcy was admitted to RIH as a result of a premature birth. She had her son, Chase, 8 weeks early and believed that the stress she suffered due to her dad's lengthy hospitalization may have been a contributing factor. The staff in the Neonatal Care Unit provided exceptional care to Marcy and her newborn son. As a result, baby Chase is healthy and strong. Marcy claims, *"The Kamloops hospital is amazing and the NICU team, incredible."* **TOGETHER** they converted an initially terrifying experience into one of life's most precious memories.

Strong love, combined with excellent healthcare, enabled the Garcia's to overcome not one, but two, huge health hurdles. Frank is fully recovered, Chase is growing and thriving, and the entire family is very grateful.

## A MESSAGE FROM THE Emergency Department

Working in the emergency department, one always expects to be surprised by the unexpected, but even the most experienced of us could not have predicted the COVID-19 pandemic and the significant impact it would have on our healthcare system as a whole but also on our local region specifically. The pandemic compelled us to be 'all hands on deck'! Our Emergency Department was already overcrowded and under strain before COVID-19 hit and suddenly we had to redesign the complete flow of our patient load through the Emergency Department. With immediate effect, the complete triage screening system had changed to allow for patients to flow through the Emergency in either red (higher risk for COVID-19) and green stream (lower risk for COVID-19). The logistics and practical geographical and structural ways to do this needed to be redesigned and placed in action at tremendous speed as the pandemic unfolded. We had a lack of negative pressure areas and had to 'manufacture' more negative areas for high risk Covid patients. The need for PPE and the logistics of making sure all staff members were safe was another huge challenge for all. The Emergency staff rose to the occasion and we had magnificent support from our RIH Foundation on financial fronts and also organizationally with aspects like resourcing. As the pandemic raged on, RIH Foundation also supported the Emergency staff with moral support on many fronts, including for example, by intermittently arranging for meals for overworked and overstressed staff. This team work was marvelous and kept the wheels of the emergency room turning. In addition, the RIH Foundation continued all its pre-COVID commitments and supported the emergency room in other ways like replacing and funding state-of-art new ultrasound machines that is now standard of care in modern first world emergency medicine. We thank the RIH Foundation for helping us through this tough year! **Together** we rose!

# TOGETHER WE RISE

Since construction began in late 2018, Kamloops and the surrounding communities have watched the new 9-storey Patient Care Tower project at Royal Inland Hospital (RIH) with interest, anticipation and questions abounding. On April 21, 2021, many questions were answered when the Together We Rise (TWR) Campaign officially launched.

The virtual launch included a presentation by Dr. Todd Ring, Chief of Staff at RIH, which gave invitees a glimpse of the beautiful interior of the tower. It includes 100+ private patient rooms, along with other highlights such as the helicopter landing pad on the roof, a spacious main entrance and inviting atrium. The new building will also include youth and adult mental health units, a new surgical floor with 13 operating rooms, maternal and child health services, a rehabilitation unit, and trauma, stroke & neurosciences units. It is the largest fundraising campaign in the history of the RIH Foundation, with a goal of raising \$35 million by 2023.

To date, fundraising has been done by a committee of volunteers, chaired by Jim Reynolds. Their efforts have been rewarded with almost \$20 million raised to-date. Funds raised will go toward medical equipment and patient comfort items located in the new Tower in areas such as the Pediatrics Unit, Emergency Department, and Post-anesthetic Recovery. Areas of the existing hospital will undergo major renovations starting in 2022 once the Tower is open. With a total project budget of \$417 million, the Ministry of Health is contributing \$202 million, Interior Health \$23 million, while the Thompson Regional Hospital District is funding \$172 million. The RIH Foundation committed to raise \$20 million for new equipment in the tower but thanks to the generous support of our donors, we committed to raise a further \$15 million to meet continual demand for priority equipment at the hospital and toward cancer care.

As the only tertiary referral hospital in our region, our facility is one that our city and region is proud of and will continue to be proud of for years to come. The 9-storey Tower and subsequent extensive renovations will dramatically change our Hospital to a thoroughly modern one, and one that will continue to provide exceptional patient care.

#### KAMLOOPS BLAZERS TEDDY BEAR TOSS

Each year, hundreds of Blazers fans gather in the stands, ready to toss teddy bears and stuffed animals on the ice to benefit children in the Pediatric Department at Royal Inland Hospital. This year, the Kamloops Blazers Teddy Bear Toss looked a little different as it took on a virtual format. With COVID-19 health and safety protocols strictly in place and Blazers games being cancelled, RIH was unable to accept any physical items, including teddy bears. Instead, participants were encouraged to make online donations and help the RIH Foundation reach their \$5,000 fundraising goal to help purchase comfort items for patients and restock the Pediatric Department's stuffy inventory. By the time the virtual event wrapped up on December 15th 2020, an astounding total of \$10,148.31 was raised to purchase teddy bears and bring joy to RIH's youngest patients! We are proud to say that the Blazers started this tradition in 1993 and now all 22 teams in the WHL, along with minor pro hockey teams, host their own teddy bear tosses.

#### RADIOTHON

On February 25th 2021, Radio NL listeners set an alltime record, raising a total of \$236,895 during the 7th annual RIH Foundation Radiothon broadcasted by Radio NL 610 AM (Stingray). All proceeds went towards purchasing much needed critical equipment for the Royal Inland Hospital's new patient care tower. Even though the event did not have a physical location, each



sponsor was given their own dedicated sponsor hour where they were encouraged to reach out to their own network via phone or text to promote donations and for that hour, all incoming calls to the Radiothon phone number were forwarded to them. For 12 hours straight, listeners tuned in to hear interviews from doctors, staff, and grateful patients. The success of this event would not be possible without the community's participation and the contributions made by our sponsors.



## Together, We Remember

Rosa Alice Rogers' undeniable zest for life, led her down the path of many adventures. She was never afraid to take chances and when challenges arose, she took them head on with her creative, clever, and feisty personality.

Born November 13th, 1928, Rosa Rogers was the second in a family of eight children, six of whom made it to adulthood. Her parents, Ernest and Lea Delisle, lived on a small plot of land in a rural town which is now known as Pascal, Saskatchewan. Her father was a restless man with numerous ventures on the go. Although he primarily farmed in the summers and logged in the winters, he also worked in many other professions running a gas station and vehicle repair service, a taxi business, the town's electrical plant, pig farming, and providing transport

trucks to local fisheries. If Ernest came across an opportunity, with the help and support of his family, he never missed the chance to jump at it and parlay it into something more.

By the early 1940's the economy began to change and as the children grew up, they felt a strong desire to pursue a life in the city. Rosa's eldest brothers left their hometown for work in Vancouver, and she was also presented with the opportunity to live in Vancouver with her aunt Annette if she agreed to complete a hairdressing diploma and work in her aunt's salon, which she did.

In 1948 Rosa married a man named Gerry Briere and within a couple years had two children, Rita and Robert. After their son was born, Gerry started work in the oil fields and this is when their gipsy years began. They were always on the move to a new place, a new town, with new friends. Rosa loved it. While on the road, Rosa and Gerry had another son David, and the family of five travelled all over Alberta and Northern B.C. in a 6 x 26-foot trailer.

By 1962, the young couple separated and

Rosa found herself back in Vancouver with her three children. A set-back was just a bump on the road for Rosa and she believed that "if you take them fast enough, you can just fly right over them!" She sold and financed numerous homes in Vancouver which eventually generated enough revenue for her to purchase a large waterfront lot on Shuswap Lake. For many years she spent her winters in Vancouver and her summers on "A life that touches others, lives on forever."

the Shuswap living in one of her MANY bikinis. Many memories were shared with Rosa and her family at "the lake."

While in Northern BC, Rosa met John Rogers, a hardworking man who later became her life partner. Although John was away working a lot of the time, the vibrant couple created a beautiful life together and spent their downtime at the Shuswap where they eventually built their permanent home.

When John's health began to decline, the couple moved to






Kamloops to be closer to the Royal Inland Hospital. After his passing, Rosa's health also began deteriorating, resulting in frequent stays at the Royal Inland Hospital until her family decided to bring her to her daughter's place in Winnipeg. On September 27th, 2018, Rosa Alice Rogers passed away. Her ashes were taken back to British Columbia and scattered from a helicopter over the hills behind her former home on the Shuswap.

Whether it be travelling, creating memories with loved ones or spending time with family at the lake, Rosa put her full heart into everything she did. Upon her departure, Rosa left a portion of her estate as a legacy gift to the Royal Inland Hospital. A patient room in the new *Patient Care Tower* will be named in memory of Rosa Rogers. Not only did she leave a lasting impact on everyone she met, her contributions to the Royal Inland Hospital will never be forgotten and appreciated by many.

## The RIH Foundation is Committed to Honoring and Supporting Our Valued Nurses Through the Nurse Mentorship Program

The Royal Inland Hospital Foundation has supported a Nurse Mentorship Program at RIH since 2016. Being the first, and only, of its kind in the Interior, five cohorts have gone through the program with an average of 19 participants per year (this includes both mentors and mentees). This year will mark the program's 6th year and cohort. The program has had individuals return a few times over to be mentors year after year.

The RIH Foundation prides itself on having the ability to support professional development at the site level, which ultimately can translate into a robustly trained nursing staff as well as the opportunity for senior nurses to participate in professional development through the program. Within the hospital, there is an extremely wide range of specialized medical care. While the RIH Foundation has committed to supporting the program, it is our donors who have helped fund critical equipment and medical tools throughout the hospital. One of the main deliverables to Mentors is gaining valuable leadership development experience, whereas Mentees benefit from the opportunity to be supported through their journey from student to staff, and also throughout their recruitment process.

A big success of the Nurse Mentorship program is evident in the conversion of students to staff, and more specific to this program, Mentees to Mentors. The cost of the program has varied depending on participants and COVID, with the highest cost being incurred in 2018-2019 at \$19,978.59 and the lowest in 2020-2021 at \$9,587.50. The total cost of the five cohorts of the Nurse Mentorship Program has come in at \$72,525.62 with an average/ per year cost of \$14,505.12. The RIH Foundation has continued to provide 100% financial support to the program and has committed \$20,000 per year moving forward to ensure the longevity and sustainability of the program for years to come.




